OFFICE MEMORANDUM

In partial modification of this Deptt.'s earlier OM vide No.AHE.331/2008/33 dated 09-07-2009 and No.AHE.331/2008/52 dated 05-11-2014 the following terms and condition i.e. (3) and (4) are added with the approval of State Cabinet regarding constituting the structure of the Governing Bodies of Colleges.

- (3) the President of Governing Bodies of Colleges shall be an eminent person from the field of Education. He shall be a non-political person. He should not have contested any election including panchayat/municipality/local bodies election or should not be an office bearer of any political party or should not have any affiliation /membership to any political party.
- (4) He shall be appointed by the Director of Higher Education and shall have a term of five years. He shall however continue beyond this period till his successor is appointed. The Director may however remove him anytime during the term of five years for reasons to be recorded in writing.

All other terms and condition as laid down in the OM vide No.AHE.331/2008/33 dated 09-07-2007 & No.AHE.331/2008/52 dated 05-11-2014 will remain same.

Sub. Amendment of "the Assam College Employees (Provincialisation) (Amendment) Rules, 2017".

Ref. Govt. Notification No.AHE.643/2016/12, dated 09-11-2017.

Sir,

With reference to the Govt. letter on the subject cited above, I have the honour to state that the Govt. in the Education Higher Department has amended the Assam College Employees (Provincialisation) Act, 2005 vide Notification No.AHE.643/2016/12, dated 9<sup>th</sup> November, 2017.

As per the amendment, the Hon'ble Vice-Chancellor to which the college is affiliated shall be the Chairman of the Selection Committee to be constituted by the Colleges for purpose of selection of Principals by direct recruitment.

The Principal of the college shall apprise the Hon'ble Vice-Chancellor and issue order constituting Selection Committee as per the Notification dated 9<sup>th</sup> November, 2017. Hon'ble Vice-Chancellor will give convenient date for holding selection and the venue of the interview may be given in the University where other members of the selection committee will attend. The Govt. has issued guidelines for selection of regular Principal vide No.G(B)CC.47/2011/75, dated 18-11-2011 which may be adhered to. Copy of the O.M. is enclosed.

The Registrar of the above university is requested to appraise the matter to the Hon'ble Vice-Chancellor.

ORDER BY THE GOVERNOR  
NOTIFICATION

Dated Dispur, the 9<sup>th</sup> November, 2017.

No. AHE.643/2016/12 : In exercise of the powers conferred under sub-section (1) of section 12 of the Assam College Employees (Provincialisation) Act, 2005 (Assam Act No. XLVI of 2005), the Governor of Assam is hereby pleased to make the following rules further to amend the Assam College Employees (Provincialisation) Rules, 2010, hereinafter referred to as the principal Rules, in the manner hereinafter appearing, namely :-

| Amendment of rule 5          | 2.  | In the principal Rules, in rule 5, for the existing sub-rule (1), the following shall be substituted, namely :- |

"(1) (i) Appointment to the post of Principal shall be by direct selection. On arising of a vacancy to the post of Principal, the Governing Body of the College shall seek approval for conducting selection procedures from the Director. On receipt of approval, the College shall advertise the post in at least two prominent regional news papers including a English Daily having wide circulation in the State giving at least 15(fifteen) days time. Also, advertisement should be given in the website of the concerned Affiliating University by the Member Secretary of the Selection Committee giving at least 15 days time. The qualifications for the post shall be as fixed by the Government from time to time. The Governing Body shall constitute a Selection Committee as per rule 10 A of these rules who shall hold interview and also recommend one candidate to the Director who shall issue the orders of appointment.

(ii) All the selection procedures of the Selection Committee shall be completed on the day of Selection Committee meeting itself, wherein minutes are recorded along with the scoring proforma and recommendation made on the basis of merit with the list of selected and wait-listed candidates/Panel of names in order of merit, duly signed by all members of the selection committee.

(iii) The term of appointment of the College Principal shall be five years or till the age of retirement, whichever is earlier, with eligibility for re-appointment for one more term only after qualifying in a similar selection process."

representing that category in the Selection Committee :

Provided, that at least five members including two experts from (v) above, shall constitute the quorum."
